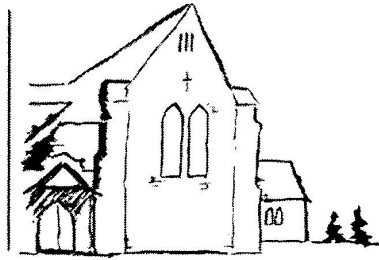

**I**f you have automatic debits going from your bank account to pay for insurance, cable TV, taxes, fuel, or mortgage, then you understand the Pre-Authorized Giving (PAG) principle. A monthly automatic debit may also be used in the form of PAG for individual(s) to make a church offering. Many people have found, and continue to find, that PAG is an easy and convenient way to honour their regular commitments to the church month by month.

As a financially self-sustaining faith community, St. Nicholas relies on the regular financial support of its members and friends. Pre-Authorized Giving helps provide this ongoing support. Unlike the more 'traditional' weekly Envelopes, PAG also helps the Parish by creating a clearer picture of our monthly income - something that is important for all families, even a non-profit family of faith such as the one at St. Nicholas, Birch Cliff.

We hope that you will prayerfully consider whether PAG would be helpful to you and are grateful for your consideration.

*St. Nicholas' Pre-Authorized Giving Program is administered by the United Church of Canada. The monthly debit will appear as "PAR CHURCH DON." on your monthly statement.*

### **What is Pre-Authorized Giving?**

Pre-Authorized Giving means that on the 20<sup>th</sup> day of every month an amount of money (chosen by you) will be automatically transferred from your bank account to The Church of St. Nicholas.

### **How Does it Benefit Me?**

- Regular support of the Church in the amount you choose.
- Avoids "catching up" at the end of the year.
- Provides a charitable tax receipt for Income Tax purposes
- Honours your commitment to the Church in a convenient way.

### **How Does it Benefit the Church?**

- Provides a regular, dependable flow of contributions to support the ministry and mission of the parish.
- Reduces the amount of paperwork and bookkeeping.
- If desired, allows you to support and contribute monthly to Parish Outreach and to FaithWorks

### **Can I Easily Change or Cancel My Automatic Withdrawals?**

- **Yes.** Your donation may be changed at any time by marking "Donor Change" on the form and returning it to the Church Office.

### **How Do I Start?**

- Prayerfully consider the amount you want to contribute each month.
- Fill in the "Pre-Authorized Remittance Form"
- Attach a "Void" Cheque
- Return the form, and "void" cheque, by
  - placing it on the Offertory Plate
  - returning it to the Church Office or
